Carolina REACT Comes Through in Train Wreck

HENDERSON, NC - On March 5, 1984 at 6:45 p.m. during a driving rain storm the regular run of Amtrak's southbound passenger train from New York to Miami was abruptly ended by a broken axle on the second engine which caused the two-engine, 18 car train to jump the tracks. The derailment sent all 18 cars, 249 passengers, and crew members down a 30 foot embankment alongside U.S. Highway #1, several miles south of Henderson. Miraculously, there were no fatalities. Fifty people were treated at the local hospital for injuries and 13 of these remained overnight. One passenger (Continued on page 8)

Indiana Teams Win 1st, 2nd **Quarter Achievement**

NORTHBROOK, IL - Winners have been named for the first and second quarter achievement awards. Named winner of the first quarter award for 1983 is Metro REACT North of Floyd County (New Albany, IN) and selected for the second quarter of 1983 is Vanderburgh County

REACT (Evansville, IN).

In naming the Metro REACT Team winner, the Achievement Award Chairman Greg Anderson cited the Team's outstanding work in support of a family in need in helping to replace an outworn and dangerous wood bridge so that one of the family's children — a victim of cerebral palsy, could be picked up by bus. The family is broke, since the father

has been unemployed for several years, and had no way to repair the bridge on their own. After contacting several organizations for assistance with little to show for their efforts, the mother approached REACT. In a matter of just a few days, REACT responded. According to the mother, "That night when I came home from work. I was surprised when J saw that old bridge was gone and the cherry tree removed. In its place was a new bridge and three truck loads of rock had been layed."

Thanks to the Team's good work, the child, who is subject to illness from the slightest exposure, can be picked up right at the door by bus.

According to Public Relations Chairman Lee Besing, Vanderburgh County REACT Team C-296 was chartered in October 1969. Says REACTer Besing, "While our name says 'Vanderburgh' County, we have active members residing in periphoration." in neighboring Warrick and Posey Counties."
The Team's Junior REACT was

chartered in January, 1981 and has proved to be an important part of its overall "commitment to the community."

The club was instrumental in starting Knox County REACT (Vincennes, IN) in 1981 as well as Pike County REACT

(Otwell, IN) in 1982 and works with Perry County REACT (Tell City, IN) and Ohio Valley REACT (Henderson,

In November, 1981 and again in 1982, the Team received the Indiana State REACT Council's REACT Team of the Year Award as outstanding Team in Indiana. During 1982, members spent more than 20,000 manhours monitoring Channel 9 in the Team's tri-county area and the outlook for 1983 is even better.

At the 1981 REACT International Convention in Indianapolis, members conducted two workshops: the Junior REACT Workshop and the Public Relations Workshop.

During the winter storms in 1981-82, Besing notes, REACT volunteers spent untold hours patrolling frozen highways aiding stranded motorists and providing transportation for Welborn Hospital personnel.

On June 8, 1982 a storm of hurricane force ripped its way through the area tearing up large areas of Evansville. flooding streets and tearing down power lines, poles and trees. When power was lost at the Red Cross Blood Center and REACT control, REACT's diesel generator powered the entire building. saving the freshly donated blood from

a blood drive in progress.

REACT's mobile communications trailer was set up and the REACT CB and Red Cross bases were back on the air within minutes. Hundreds of calls on Channel 9 were handled and units were dispatched to handle traffic at flood routes for emergency vehicles to get through. According to Besing, the Team spent over 400 manhours during and after the storm and were commended by the Mayor.

In November of 1982 the Team installed 11 highway signs on major streets and highways in the Evansville area informing the motoring public that REACT is on Channel 9 to help them. (Continued on page 7)

Survivalist Group Urges Use of CB Channel Seven

CHICAGO, IL - At the suggestion of many members and affiliated groups, Live Free, Inc., a not-for-profit, education, communication and network service organization for the now international survivalist movement, has undertaken the task of coordinating and promoting the use of citizens band Channel 7 as a recognized survival communications channel. The organization believes that following benefits would result from the general recognition and use of what they call "Survival Seven:

- I. It would encourage CB Communications in general between individual survivalists and survival groups.
- It would facilitate the dissemination of vital survival information to sur-vivalists as well as friends and neighbors
- 3. It would provide a known channel on which survivalists could try to es-

tablish initial communications with other survivalists_in_the_area_without_ compromising his or her base location.

- It could serve as a monitor channel for initial survival alert warning communications.
- It could be used as a "normal opera-tions" channel for groups conducting training activities.
- 6. It would promote: network formation, unity and comradeship among

unity and comradeship among survivalists.

Live Free, Inc. will have "Survival Channel 7" bumper stickers available soon and the organization has directed all of its members to begin regular use and monitoring of Channel 7 for survival related communications. Gudridge Takes 1st Quarter Individual Achievement Award

Winner of the first quarter award for Achievement — Individual is Richard D. Gudridge who recently was saluted for his service to the community (see March-April REACTer) and who is spearheading the effort of the Minnesota State REACT Council to introduce legislation which would make deliberate interference on Channel 9 a crime (see story on In submitting its nomination the St. Cloud REACT Team writes:

A. "Richard is currently serving his fifth one-year term as Public Relations Chairperson for St. Cloud REACT, Inc. 3791. Through his drive, devotion, and spirit of REACT leadership, he has performed an exceptional task of telling 'the REACT story' of people helping people on live local radio stations. He has done live interviews ranging from 15 minutes to one hour; which lead him to developing 'winter driving tips' for use on our local radio stations and adapted by MN Team Council for release state wide for use free of charge to all REACT Teams of MN upon request."

B. "During the first quarter of 1983, Richard has logged and reported over 700 hours monitoring Channel 9 on his base. During this quarter, Richard has logged and reported over 851 hours monitoring Channel 9 on his home base with a running total, so far as of June 30, 1983, of 1551 hours. This is true dedication.

"Late in 1982, Richard, along with one of our directors attended a Cub Scout Jamboree representing several of our local Cub Scout troops as a guest speaker from REACT to illustrate proper use of CB radios and the purpose of Channel 9 for emergencies. Among that group of individuals that evening, another distinguished man of Minnesota stepped forward and spoke to Richard saying, "after I'm elected, if I can help you, feel free to contact me." The distinguished person was the Honorable Governor Rudy Perpich of the state of Minnesota. Richard remembered and called Gov. Rudy Perpich for an appointment and an appointment was made for March 9. At the appointed time, Richard, along with two members of MN M.R.T.C. discussed with Governor Perpich and members of his staff, the Assistant Director of Emergency Services and Assistant Director of Department of Public Services of MN the purpose of REACT and how we can help (Continued on page 8)



Kevin Goes International

The young man standing on the antenna tower is Kevin Parrish. Kevin started off with REACT as one of our youth members. With Kevin as a friend, we really don't need any enemies. Getting him out of scrapes for cutting school, transmitting on police frequencies, carrying a gun through hostage lines, etc., required "another" full time Team Officer. Then, in continuation school he discovered the video camera. He freelanced — then became staff cameraman for our local Channel 2. He now has been hired by ABC to join their international staff out of New York. You won't see him but you will see his work you will see his work.

The justification for showing the picture in this column is that, as a going-away gift to his home Team. Kevin reorganized the Team's antenna system, paying for much of it himself. He is standing on the cross-arm of our new professional Rohn Antenna Tower. The center antenna is our new double duty GMRS beauty which feeds into a new Celwave duplexer and into an ancient Motorola repeater. The cross-arm will hold one 27 MEG big stick, and a scanner antenna. Our beam antenna, and another big stick 21 MEQ big stick, and a scanner antenna. Our beam antenna, and another big stick for a second set (for Team business) are located separately and about 25 feet from the tower to minimize interference on 27 MEGS. The project gave Kevin the additional opportunity to install hard wire cables and "N" type connectors, and definite grounding all around.

The point, of course, is that your home could have the same gathering of antennas what with a 27 MEG big stick, a scanner antenna, and now something for your GMRS base operation. Maybe you should be thinking of a Rohn Tower for your home, and get that mess off of your roof.

You are probably no different from any other Team in REACT, and unless you share a GMRS repeater or share a monitoring schedule, you rarely ever see or talk to members of neighboring Teams and especially Teams located 200 miles away. Well, your Council, if it does nothing else, provides you with the opportunity of sitting across the table from some other REACT member from far away and exchanging ideas, complaints, and suggestions. The Northern California REACT Council is one of three Councils in California. It has a long history of regional meetings, going back to its predecessor—the NOR CAL CB Calendar Committee. We meet every three months and we schedule our meetings about one year in advance, trying to meet at different areas, to try to attract different "short distance travelers."

At our February meeting in Marysville-Yuba City, CA, Walt Pennington, Unit 32 of Butte County REACT, told of their "Operation Talk to Santa," which they have conducted very successfully in this Northeastern, California area. They take their REACT van to a shopping center parking area (obviously too small to have a full blown Santa) and they invite smaller children to talk to Santa by radio. They show the child the radio to Santa. Santa is parked across the parking lot so he can see the action but can't outwardly be spotted and he answers on the radio as Santa should. 

REACT faced many challenges in 1983.

First there was a financial challenge. This was recognized by the Board of Directors at the February meeting where they voted to increase dues for 1984. The announced increase from \$7\$ to \$10\$ for 1984. The announced increase from \$7\$ to \$10\$ for 1984. The announced increase from \$7\$ to \$10\$ for 1984 of the 1983 from \$5\$ to \$8\$ for Family and Junior members was a cause for concern. However, by July at the 1983 International Convention in Wichita, the need was clearly seen. A projected \$35,000 deficit for 1983 certainly required an increase in dues for 1984.

This produced the management challenge to provide the maximum in services, reduce expenses and find additional long term solutions to the financial problems of REACT beyond the immediate scheduled dues increase.

Outside Audit Approved

Coordinated efforts of Headquarters staff, Board of Directors and the Special Committee on Fundraising produced an outside auditor's evalua-tion of REACT's financial matters, recommendations for changes in procedures, and a verification that control of funds was on a honest and accurate

that control of lunds was on a nonest and accurate basis at headquarters.

The Special Audit Committee of Bill Appel of Michigan Emergency Patrol, Detroit, Michigan: and Reid Jones of Roanoke Valley REACT, Roanoke, Virginia; came to Chicago, hired the firm of Deloitte, Haskins and Sells (a "Big-8" CPA Firm) on behalf of REACT International to do this job.

Their report identified areas requiring attention lating to accountability while substantially for Their report identified areas requiring attention relating to accountability while substantially for basic financial integrity of REACT's administration. Recommendations for improved handling of funds were included and implemented. The new accounting methods are reflected in the professional independent audit accompanying this report.

Meanwhile, headquarters efforts to reduce expenditures included a voluntary 10% salary cut for the Executive Director. Increased income from advertising sales for The REACTer and Life Memberships helped to reduce the eventual deficit to under \$7.000, as reflected in the report herewith.

A loss of \$4,730 resulted from operations of REACT International, Inc., while Official REACT Supply. Inc. showed a loss of \$2,259 for a total of \$6,989. This includes an allowance for Federal and State Income Taxes of \$1,170 for net profit on REACTEr advertising income for REACT International, and inventory write-offs of \$2,112 for obsolete materials charged to Official REACT

1984 Dues Goal Achieved

The Board of Directors at their January 1984 meeting forecast the possibility of a membership loss of 34% from the previous year and approved a budget on this assumption. We are pleased to report at this writing that 1984 dues income has surpassed budget projection of \$113.000. This basefully secures a year without defect sevending. basically assures a year without deficit spending.

The Board of Directors has authorized a special The Board of Directors has authorized a special Greeting Card Fundraising Program to further increase income at no risk to REACT International. Enthusiastic participation in this program could reduce the deficit significantly and possibly even eliminate the total \$12.657 deficit carryover. In the meantime, services to Teams have increased with products from the REACT Forum being sent out to the Teams.

Special advertising sales permitted publishing and distribution of the 1984 REACT Team and distribution of the 1984 REACT Team Directory during the final quarter. A confidential Emergency Contact Listing for registered Team/ Council use is being prepared for release prior to the 1984 International Convention. (1) DESCRIPTION OF OPERATIONS AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:
The Company is a tax-exempt organization formed to develop and promote the use of the Citizens Radio Service and other personal radio services as an additional source of communication for emergencies, idealers, and other forms of aid to citizens. of emergency Channel 9 on CB radio and extensive public service involvement with local community service agencies and local disaster response organizations.

REACT continues in 1984 to be a highly active organization involved with many other groups such as the National Voluntary Organizations Active in Disaster; National Highway Traffic Safety Administration for promotion of the use of vehicle safety belts and child restraints; and a lead organization in the CB Radio Coalition Against Drunk Driving.

The encouragement of the public to report their Impaired Driver Alert via CB radio from the highway directly to a REACT monitor or other emergency channel monitor is an important factor in the growing campaign against drunk driving.

REACT Fights Drunk Driving

Many states and local communities are joining in Many states and local communities are joining in efforts to reduce alcohol related traffic accidents including participation in the REDDI Program with federal funding incentives available. A survey indicated that better than 90% of American motorists would report the behavior of a drunk driver on the highway with the CB radio were one available. REACT is working with MADD (Mothers Against Drunk Driving), SADD (Students Against Drunk Driving), RID (Remove Intoxicated Drivers), AAIM (Alliance Against

Intoxicated Motorists), National Highway Traffic Safety Administration, Highway Users Federation. Satety Administration. Highway Users Federation, and many other governmental and private sector agencies campaigning to remove drunk drivers from our highways. This has become a major highway safety effort in which REACT is engaged in 1984. REACT has cooperated and received significant support from the insurance industry in this effort.

In addition to the above highway safety disaster preparedness activities, REACT is also affiliated with the Neighborhood Crime Prevention Coordinating Committee, for the stimulation of citizens participation in neighborhood patrol activities and other types of programs such as the Neighborhood Watch Program.

REACT policy regarding membership has been REACT policy regarding membership has been modified through actions begun at the 1983 REACT Convention in Wichita. This provides for the acceptance of new REACT Teams who wish to participate in a variety of activities. Maintenance of the major REACT objective of monitoring Citizens Band Emergency Channel 9 will be achieved through motivation rather than compulsion. The idea is to foster participation of local communicators into the REACT effort by providing opportunities for membership in an internationally recognized organization. This initiation can be expected to result in additional REACT Teams and added membership for existing Teams. As we enter 1984, REACT faces the future with a

As we enter 1984, REACT faces the future with a sound plan for dealing not only with present problems and public service needs, but in being able to adapt to the unforseen opportunities available through future developments.

where that was. In the meantime, the CBer was calling me back wanting to know how soon they would be there with some help . . . a question I could not answer. He called back about 5:00 p.m. and said that a helicopter had passed over and apparently waved to them and then went on not to return. At 5:30 p.m. I received a call from CHP again asking if the CBer could transport the people, who by now had made it to the road, down from the location to the base of the mountain. The CBer indicated that he could and said that it would take about 30-45 minutes to get down to an agreed upon location identified as the "Jump off." I relayed this to the CHP. They said that a sheriff vehicle from San Bernardino would meet them there. The County CBer called me at 6:00 p.m. to tell me that they were at the base of the mountain but that there was no one there to meet them. I called the S.B. Sheriff's Office and they told me that the information had been relayed back to CHP and they would meet the party at the location which was Saffire Road right off of 19th Avenue. That was at 6:10 p.m. I received another call from the CBer at 6:30 p.m. that the CHP had arrived. At about 6:35 the CBer called again to tell me that everything was under control and that the CHP would transport the people to a facility where they could be treated for scratches and bruises and the driver of the vehicle that went over the side would

be treated for mild shock. He thanked for staying with him until everything had been taken care of and said he was sure glad we were available to help. I told him we in turn were happy to be of assistance, wished him a good evening and signed off.

MN Council Steers Anti Jamming Bill to Legislature

ST. CLOUD, MN - The Minnesota REACT Team Council has successfully worked to get a new proposed law before the Minnesota State Legislature. Senator James Pehler, St. Cloud, is authoring the bill and has submitted it to the Senate Rules Committee for numbering and placement on the Senate calendar.

Similar laws have already been enacted into law in Illinois, Oklahoma and Texas. We, at M.R.T.C., feel that this law can act as a good deterrent to deliberate interference during emergency communications. Most REACTers have experienced "jamming" when receiving emergency communications and we all know how hard it is to get the FCC to take action.

We now need the assistance of all REACT members. 
than ever before!
The UHF-FM radio system, formerly called class "A" CB radio but renamed the General Mobile Radio Service by the FCC, has an operational area that extends from Casper mountain with a radius of from 50 to 75 miles depending upon direction. Strategically placed relay operators receive road and weather information from passing motorists and truckers on CB channels and through personal observation. This information

is then passed on to other monitoring stations in the FM system, who can then answer information requests on regular CB channels in their areas. Anyone who owns a scanner capable of receiving UHF-FM signals is also able and welcome to receive and distribute this data.

The UHF-FM radio system is especially well suited to this kind of usage because there is never any of the long distance "skip" interference normally associated with the regular CB channels. Another advantage of the G.M.R.S. system is that it uses FM instead of AM modulation resulting in higher quality voice communications.

Significant contributions to the UHF-FM system have been made by many individuals and businesses like Mountain Bell, most recently a large donation of equipment, mountain-top repeater space, and engineering support by Two Way Radio Service of Casper.

Fundraising projects by REACT Team members, monetary and equipment donations, and service support are taking place to expand the system to its full potential. Partially Paralyzed Child Receives Stroller from REACT

CHATHAM, ON - Jason Bedfored is wheeling around town today with a lot more ease and comfort in the king-size stroller he received recently as a special gift from a local Citizens Band Radio Club. "It's beautiful," said parents La

'said parents Larry and Carol Bedford of Chatham when members of Maple City REACT presented the stroller to the child at the Kent County Children's Treatment Centre.

The 19-member club bought the \$310 stroller after learning the 21-month-old child, who is partially paralyzed on his right side, had grown out of his regular size folding baby stroller.

Carol Bedford said she was looking forward to the new stroller, noting she has had to carry the child around for the past few months because the old stroller is too small. " weighs 28 pounds. He's very, very heavy." She said she will now be able to start taking her son on her shopping trips and for walks around the city. "He really loves his new stroiler," she said later Friday. "He was giggling in it and everything."

Jason has been receiving physiotherapy, speech and occupational therapy treatment at the Children's Centre twice a week for the past year. Bedford said she first noticed

at the Children's Centre twice a week for the past year. Bedford said she first noticed the paralysis when he was 6 months old and wasn't moving one of his right fingers. Betty Yundt, a physiotherapist at the centre, said Jason has been making rapid improvement. The paralysis throws off his balance and makes movement difficult. She said the child's major milestone to date has been in trying to stand up. Bedford said her son first started trying to stand up about two weeks ago. He already crawls, which Betty Yundt said is good for his co-ordination. The use of his right arm has also vastly improved.

Jason's new stroller is designed to carry a child weighing up to 63.5 kilograms (140 lbs.) and was purchased from a medical company in Montreal. It folds easily to fit inside a car.

Club President Kevin Almas, 22, said the money for the stroller was raised by holding a bingo game. The club wanted to donate to a needy cause and went to the treatment centre for a suggestion.

He said the gift marks the first time the club has donated directly to an individual. Membership in the club has dwindled from its peak of about 75 members in 1978, but the club is still aive and well, he said. Larry Bedford, 26, a taxi driver, was a club member in the late 1970's.

Almas said he feels pretty good about helping the Bedfords. "I think it's going to help Jason quite a bit.

in emergencies

SKYWARN

Two-way radio is the backbone of Skywarn — the National Weather Services system to spot severe weather and warn the public of possible emergency or disaster. Weather

to spot severe weather and warn the public of possible emergency or disaster. Weather radar is unable to detect and locate all funnel clouds or tornados, so the spotter is and will remain necessary as the "eyes" of Skywarn.

A short course (2-3 hours) explains what to look for in approaching storms, how to distinguish tornados from "look alikes" and procedures for reporting "spots" to the Weather Service. A Spotter Guide, indentification card and other materials are furnished. Some local civil defense units, also part of the system, provide certificates of training, uniform patches and auto decals.

There is no better way to use CB or GMRS and lives are certainly saved every year by Skywarn. Check with civil defense or Weather Service offices for local program information. If not established, consider helping start it up. The life you save may be your own!

Boater Assistance

Channel 9 was originally established for assistance to motorists, but many pleasure boats also rely on CB for emergency communications rather than marine radio. If your monitoring station is near a major river, large lake or on the coast, you may receive emergency calls, especially during the summer months. Boats may be dead in the water, damaged by collision, aground or afire and asking for immediate assistance. If you must

damaged by collision, aground or affe and asking for infinite dual assistance. If you must relay a request for boater assistance, do you know who to call?

The Coast Guard (and its volunteer auxiliary) has responsibility for Search and Rescue at sea and on navigable waterways. They are spread pretty thin. A local police or fire department, or a state boating safety agency, may also be responsible. The U.S. Army Corps of Engineers may be able to respond near locks and dams or there could be a water rescue squad in your area. If you and your Team are subject to receiving calls for boater assistance, DO inquire into which agencies can respond and get their phone numbers. Things change, so check again every spring before the boating season.

NOAA Weather Radio

National Weather Service, part of the National Oceanic and Atmospheric Administration (NOAA) of the U.S. Department of Commerce, operates more than 350 VHF-FM Weather Radio stations. If you are in range of a station, it will offer the best direct warning for both natural disaster and nuclear attack. The frequencies (MHz) in use, or planned future use, are: 162.400 162.425 162.450

162.550

Most stations operate 24 hours daily with taped forecasts and are usually heard easily within 40 miles of a transmitter. This range can be extended by using a high outside antenna. The frequencies can be entered into a programmable scanner or may be received on some home or portable radios with "weather band." Better are the "warning alarm" receivers that remain silent until an activating tone is broadcast or you turn it

On February 22, 1975 a young Oklahoma man was killed by lightning while working on a TV antenna. On May 21, 1975 a man in Michigan was killed while working on an antenna (type unknown). They were part of the approximately 200 people killed that year by lightning. Lightning is extremely dangerous, especially to anyone outdoors

during an electrical storm. It can also damage electronic equipment.

Your automobile is one excellent lightning shelter. The other is inside a building. Very few lightning deaths or injuries occur to people indoors. Your antenna mast should be well grounded and it may then offer some protection (similar to a lightning rod) for the building. Lead in cables to base stations and receivers should have lightning arresters installed. Contrary to popular belief, transmission loss is minimal. Unfortunately, very few people bother to ground or install arresters. If you don't have lightning protection, disconnect antenna cable from the set and unplug the power plug. Regardless of your protection (or lack of it) DO NOT use your base station (or telephone) during an electrical storm. Even if you are a tornado spotter, use good judge-

ment to protect yourself. Sign off as the storm nears your location and let the next

spotter behind you take over.

REACT Proves Equal to 10-inch Snowstorm in Indianapolis

INDIANAPOLIS, IN snow storm that roared through Indianapolis kept Circle City REACT busy from 6 a.m. Monday until midday Wednesday during February. Seven REACT units helped man the central

base station during the storm.

When news of the storm first hit Indianapolis about 7 a.m. Monday, REACTer John Regula began receiving numerous calls about reduced visibility, flowing and drifting snow, stalled cars and accidents.

By noon, member Doug Latimer was swamped with requests for road information, accident help and tow trucks. Team member Jack Murrell soon came to the rescue and helped Doug get the calls that

were coming into Central.

By 6 p.m. Doug, Jack and Andy Cockren were busy handing out road information, sending help to stranded motorists and monitoring the storm path. Andy Cockren was busy monitoring 2-meter frequency to find road and weather conditions west of Indianapolis.

Jack Murrell began receiving calls for assistance from Marion County Hospital workers who needed help getting to work. Following a broadcast by Doug over WIRE and WXTZ, the volunteers for 4-wheel drive assistance began calling.

Jack plugged several volunteers into the requests for assistance and many hospital workers were able to get to and from work because of REACT assistance. WIRE furnished dinner for entire crew, prepared by the Sheraton Meridian Deli.

By 8 p.m. only light snow was falling and the National Weather Service was predicting a "break in the snow" until around 2 a.m. The crew went home with no idea of what might be in store the

Tuesday was a mess! At 4 a.m. the snow began falling again and winds were in excess of 30 mph! County roads, inter-states and major downtown streets began to quickly drift shut.
