Activities at the 1991 Convention: A "Special Event Station," including HF and packet operations, was operated from the convention site. National Traffic System message service was provided to the convention attendees. Copies of Super-Morse, a shareware morse code training program for the IBM PC and compatible. were distributed to interested Volunteer Exam parties. testing was held (see below).

VE Testing: A Volunteer Exam Test session was held on Tuesday evening, July 23rd. Fifteen individuals participated: 11 convention attendees plus four local amateurs. Special thanks go to AB4NQ, AB4VR and NICVN, three local VEs who made the session possible. Of the convention attendees, six received at least some examination credit: Rene Coppedge, Jeff Lawless, Norm Kaplan, Roger Andrejco and Eric Ward passed

Element 2, the Novice Theory test. Congratulations to Frank Jennings who passed Elements 2 and 3A which qualify him for a Codeless Technician license!

Plans for 1991-1992:
Azella Tingler was appointed Membership Chairperson, she will be developing a packet of information to send to members. The Sunday afternoon 10 Meter Net (28.380 - 28.400 MHz) is moving to 2030 UTC. Work was initiated to make available training materials for

Technician Class license candidates. Plans are being made to have a Special Event Station, Amateur Radio Classes and VE Testing at the 30th Anniversary Convention in 1992. Finally, copies of two morse code training programs - SuperMorse (IBM and compatible) and WD4CPF (Commodore 64) are available by writing KA3EQT. A \$2.00 donation to cover the costs of duplication and mailing is requested.

There are two good promotions for shortwave listeners this year. HCJB has a drawing to celebrate it's 60th birthday (prize is a free trip to Ecuador) and Radio Habana Cuba celebrates 30 years with an easy contest (top prizes are 5 free trips to Cuba). Contact stations for details or listen in. There are several interesting international radio contests each year and somebody who enters always wins.

Several international shortwave stations are either already using or testing SSB transmissions. Usually this is "Compatible SSB" (CSSB), which can be heard in both AM and SSB receiver modes. All international shortwave broadcasting will eventually be exclusively SSB.

Anyone interested in a foreign language may be able to study it via radio. German, Japanese, Chinese, Russian, French and a few others are periodically available to shortwave listeners. Texts are low in cost or sometimes free so these language lessons are a real bargain.

The Association of North American Radio Clubs (ANARC) will meet this year in conjunction with the Monitoring Times Convention, Knoxville, October 4, 5, and 6. The ANARC SWL Net is still going strong on 7240 KHz LSB, Sundays at 10:00 a.m. eastern time in the U.S. Net controls are KW3F and N8J2X. Tune in for the latest DX SWL tips.

I really enjoyed the European DX Council meeting in Spain. EDXC-92 will be at Hotel Rosendahl in Tampere, Finland, August 14-17, 1992. Write the Finnish DX Association, P.O. Box 454, SF-00101 Helsinki, Finland to get on the mailing list for additional information when available. EDXC -93 will probably be held in the Canary Islands according to very tentative planning. See you there?

Over the past two years the Life Member Committee submitted a couple of proposals to the Board of Directors for action:

The following topics were discussed during Round Robin Sessions at the recent REACT International Convention.

A. Building Team Membership

Develop and promote the Junior membership program within your team. A one on one contact with interested potential members. Involve more non-REACTers in public functions. Promote REACT and your local REACT Team with new CB radio sales through local retail stores. Contact schools and issue flyers on REACT and your local Team in the Driver's Education handbooks as well as having REACT information available in the classrooms.

B. Team Member Retention & Motivation

Plan enough activities on your local and state level to involved all REACT members. Contact and arrange to have speakers on a variety of topics at your next team or state meeting. Present recognition awards for outstanding members, give your members praise at every opportunity. Personally contact those members who are now less active and encourage any inactive spouses to participate. Always have a goal to work toward. Consider members preferences for partners in team activities, thus creating more unity within the team. Offer and promote activities which are social in nature, not all work. Have a backup plan for functions in case a member does not show up. Encourage attendance at regional,

state and international meetings. Above all share thank you's with your fellow team members.

C. Introducing REACT To Others

Distribute business cards

(assistance cards). brochures. pamphlets and membership applications. Advertise or contact your local radio or TV stations for talk show spots. Conduct team membership drives in your local mall. Have a member of your team on the

local speaker's bureau. Volunteer the team to assist in community service functions, such as child or elderly searches. Offer to assist other community service groups, then invite them to your team or state meeting. Be visible and professional at all times and don't forget to wear your name tags. Display your REACT flag in a public place. Explain to individuals who cannot reach REACT why they should go ahead and broadcast (CLIP) then let them know why they should volunteer. Keep your community service vehicle in the public eye. Most important of all - be ready to explain

what REACT is, its' purpose and functions.

D. Fundraising

FROM

HEADQUARTERS:

Apply for grants on a team or state level. Hold safety breaks (where permissible) throughout the busy travel

> periods. Get your team involved in bingo and yard sales as well as commercial fundraising events (candy sales and music shows). Contact the United Way to find out how your team can get involved.

Attendees at the Convention let it be known that they wanted a "Round Robin Report" in the REACTER, Barb Chuven has been gracious enough to accept this task with the help from the membership. If you have any ideas or suggestions you would like to see, please mail it to Headquarters. All suggestions and ideas will be forwarded to Barb. Remember, to make this column work, we need your input.

SUBJECT: WHAT ABOUT CITIZENS BAND?

QUESTION: You usually talk about Amateur Radio, the Civil Air Patrol, and public safety radio services in your Bulletins. Isn't Citizens Band radio viable anymore in emergency services agencies?

ANSWER: Yes, in some areas. Because it is short range and local in nature, CB radio is best suited to city and county communications.

Like any other volunteer

service this can vary from area to area. In many areas the REACT or Radio Emer-Associated Commugency nications Team organization is a highly developed, dedicated and professional group that is a pleasure to work with and a credit to the com-CB radio now also munity. includes the GMRS or General Mobile Radio Service. This enables a professional quality base, mobile and repeater operation in the UHF-FM band.

A CB radio should be part of any city and county Emergency Operations center even if there is no organized or dependable CB radio organization. It can be an immediate source of information or reports in some instances. It is an inexpensive communications resource that should not be overlooked in any local area Emergency Operations Center.

Ballots were mailed to all REACT Teams with specific instructions on filling them out as well as mailing direc-The ballots were tions. picked up at the Melbourne Post Office by Mr. Walt Young and me on the deadline date of July 20, 1991.

The Election Committee consisted of: Tom Macussi of New Jersey: Frank Jennings of Washington; Eric Power of Florida; Deanne Earwood, Office Manager of REACT

International, Inc.; Stuart Meyer, At Large Director; Dr. Hall Duncan, At, Large Director; Ronald McCracken, President; Robert Riechel. Field Director: Jacki MacDonald, Field Director and myself.

In all 223 ballots were received and certified that all ballots received were from active REACT Teams. Of the 223 received a total of 19 were determined to be spoiled ballots. Some of these ballots did not have the signatures of the team officers who conducted the election process. Others ballots only had one signature. Those ballots with only one signature were checked to see if they were from a small team, less than five members. where there might be only

one officer, and were determined that all were from larger teams. For that reason, they were noted as spoiled ballots and not counted. Other reasons to be considered a spoiled ballot were insufficient certification, no ballot envelope used in the certification envelope and late delivery.

The ballot envelopes were opened and counted by six members of the election Two members committee. read and checked to make sure that the name called was actually the person voted for. Totals for all candidates were checked after every 20 ballots to make sure all individuals counted accurately.

Training & Development Committee

SHARPEN YOUR PENCILS AND CLEAN YOUR READING GLASSES

The day has arrived. The Training & Development Task Group is proud to announce that a program for membership training has been approved by the delegates and the Board of Directors at the 1991 REACT International Convention. The Board has also changed this Task Group into a Committee since this will be an on-going service for the membership.

STANDARDIZED TRAINING FOR MEMBERS

This is a Self-Training program which can be done on an individual member basis and does not have to be done as a Team or Council

project. Participation is voluntary! Each member can pick and choose which subjects they are interested in sending for. The individual member can then take their time studying the training booklet. When they feel they understand the material, they can complete the test questions and return just the test sheet to the REACT International office. The training booklet is theirs to keep for future reference. After their test has been checked for correct answers, and it is 75% correct, they will receive a certificate imprinted with their name, the title of the training subject and the date.

TESTING -- A DISTANT SECOND TO LEARNING

If a member doesn't get 75% of the answers correct, they will have their original test returned with the inaccurate questions highlighted. They will also receive a new blank test sheet, for a second try. The Amateur radio service usually charges students each and every time they want to be tested (may differ in your area). We are giving our students two chances to pass the test included in our cost. Since our major concern is to insure the member learns the information, this is in reality an open book test. Right and

wrong are secondary to having the student know the material. The testing will only confirm that the member has gained the knowledge.

CERTIFICATE FOR EACH SUBJECT COMPLETED & RECOGNITION IN THE REACTER

The award certificates are attractive professional certificates (8-1/2" x 11") with black and orange filigree along the outside edge. One certificate will be awarded to each individual REACT member for each subject completed. There will also be a Special Recognition section in the REACTer listing those who have completed the Training subjects.

SUBJECTS AVAILABLE

Right now we have one subject ready for immediate release, Monitoring. With the second subject, GMRS Guidelines following shortly thereafter. Even though the GMRS Guidelines won't be available until later you can pre-order the subject and still get the "introductory" price (must be postmarked by December 31).

MONITORING

The Monitoring Training has been taken from an excellent booklet developed by the Forum Monitoring Task Group in 1982. This booklet has been out of print for many years and has been sorely missed. Russ Willis has worked on the minor updating that it needed and it's now ready for training new members and as a refresher course for seasoned members. It includes the proper procedures for the use of CB Channel 9, the handling of emergency and nonemergency calls and coordination of a monitoring schedule. All the necessary information to get you on the air and helping motorists by monitoring Channel 9. The procedures outlined can also be applied to many other radio services.

GMRS (General Mobile Radio Service) GUIDELINES

The GMRS Guidelines Training has been developed by the 1990-1991 GMRS Task Group headed by Bill Simpson. It covers the history and introduction to GMRS, an explanation of the FCC rules and regulations, how to get a GMRS license, a list of GMRS terms and how to supplement your CB channel 9 monitoring using GMRS is a personal GMRS. land mobile radio service that is available to individuals and can enhance your present radio capabilities whether your Team uses it or not. Now you can get the basic training for GMRS usage.

PRICING

The "introductory" price for each Training Subject will be \$6.00 per subject, per student. This means that if REACTer "A" wants both subjects currently offered, Monitoring & GMRS Guidelines, he/she would send \$12.00 to the REACT International office for the training materials and tests. If REACTer "B" only wants the Monitoring training and test,

he/she would only send \$6.00. This price is in effect only through December 31st, 1991. As of January 1st, 1992 the price will inch up to the equally low price of \$7.00 per subject, per student.

MORE SERVICES FOR MEMBERS, WITHOUT RAISING DUES

This is meant to be a self-supporting program. No dues money will be used. The price the members pay for the training program will go for buying the certificates and the envelopes, the printing, and the postage. Plus there is the time the staff at the office must use preparing the mailings and the grading of the tests. I think you'll agree that this is a good deal for what is being charged. Any revenue generated, which will depend on how many members participate, will be used to develop other training booklets.

HOW TO ORDER

On page 16 is a registration form for you to use to sign up for one or both of the training subjects. Be sure to give your name and address (print please) and your Team number and your individual member number off your current REACT ID card. Use one registration form for each student.

Please write me with your ideas for REACTer articles or subjects you'd like to see available as training courses for the future of your organization.

Team #3111 working hand in

two different check points
this year.

We had 90% participation in the Walk-a-thon. The Walk-a-thon has got bigger every year, although this year the number of walkers was slightly less due to the recession and tight money. Allowing for this, Big Bear Valley raised in excess of \$10,000 for the March of Dimes.

The Walk-a-thon is only one of several regular events that we participate in throughout the year, including working with Bear Valley Emergency Services. This also includes all the official emergency agencies in the valley.

On March 2nd of this year we had a chance to participate in a very significant role during a local snow emergency. All main highways were closed due to snow slides and blizzard conditions. Mother Nature dumped in excess of four feet of snow within a twelve hour period causing several avalanches, power outages, and disruption. phone

Team #3111, worked in cooperation with Bear Valley Emergency Services, the fire department, sheriff's department, and highway patrol, opened up an emergency shelter. In all, 122 people were rescued having been

caught in the avalanches. We helped provide sleeping facilities, hot drinks, food, blankets for 102 people until the roads were finally cleared the next day. Because of the severity and amount of snow, the main access road in and out of the Big Bear Valley was closed for seven days.

VITALLY IMPORTANT

During a recent (KEEP AWAKE) Safety Coffee Break, at an isolated rest area along I-90 ERIE COUNTY REACT of Pennsylvania received ten (10) calls for assistance in twenty (20) minutes.

The Team received these calls over CB Channel nine (9) and relayed them on a (donated over the weekend) cellular phone.

One of these calls they worked for nearly three hours. The Team member heard a very weak signal, "Please help us or we will die."

The Team member called back to them saying, "Repeat your last message, over and over again." By doing this, the Team members were able to get the necessary information for the authorities.

The message was, "Arizona family trapped in Bradshaw Mountains, overturned in a ravine, due west of Canyon City, Arizona, off of I-17. Send help or we will die."

could only pickup bits and


