# REACT Makes Suggestions, Tandy Promises Support

Radio Shack stores.

In December, Chairman of the Board Frank Jennings, Vice-President Chuck Thompson, and I visited with an executive of Tandy/Radio Shack in Fort Worth. We presented proposals for two new kinds of two-way radios. The reason is that, in spite of major efforts by many of our members, we feel that there won't be significant growth in *REACT* until a new and very interesting radio service attracts a large number of new buyers, some of whom might join our organization. When details can be revealed without jeopardizing the secrecy necessary to commercial development, we will publish complete information about the proposed new types of radios.

We also discussed ways that REACT and Tandy might cooperate. Chuck Thompson suggested that Radio Shack offer a discount coupon to RI members. We also discussed the need to develop more Teams outside of the U.S. and Canada, to fulfill our goal of being a truly international organization.

Regardless of the outcome of our proposals, Radio Shack has agreed to put the REACT logo and information about RI in their monthly flyer, beginning in April. This is no small exposure: the flyer is mailed to 8 million customers every month!

Beginning next summer, REACT will be mentioned in a flyer packed in every CB radio and scanner that Radio Shack sells. Again, we're talking about big numbers. Radio Shack sells about 40 percent (240,000) of all CBs in the U.S. When scanners are added, the total is more than

a half million per year. (Thanks also to Norm Schrein, publisher of National Communications Magazine, who created the flyer and graciously agreed to let us piggyback.)

REACT and Radio Shack – a potent combination for growth in the New Century!

from all over the country (and I'd like to have yours, too!). In the Waukesha (Wis.) REACTer, Shawn Howe wrote, "Sure is nice to have GMRS, ham, etc., but how can the vast majority of the public call us there? We have to make our presence known. This can attract members, too!"

Bingo! Give the man a seegar!

Since 1962, we have been helping the public through radio communications. At first, that only meant talking on CB. Then came GMRS and amateur radio. Some Teams even monitor VHF and marine frequencies, and have licenses in VHF or UHF commercial bands. All of it is still a direct, person-to-person contact that can help people. But how about indirectly helping a lot more people and "making our presence known"?

Drivers fight increasing traffic congestion every day. Any tips to avoid an area due to accidents or other tie-ups are helpful to the public. We can use our two-way radios to help by making arrangements with traffic broadcasters. We can be their eyes and ears.

In some 85 cities around the U.S., Metro Traffic (a commercial service) provides AM and FM broadcast stations with traffic reports. Air-Watch is a similar company, also operating under the names TotalTraffic or Airborne II; they plan a major expansion beyond the eight cities they currently serve. (Continued on Page 12)

# FCC Enforces the Law in Southern California

outhern California GMRS, law enforcement, and other public service frequencies have been subjected to malicious, obscene transmissions during the last quarter of 1999.

combined effort among the FCC, California Highway Patrol, and local agencies culminated in the arrest of 63-year-old lack Gerritsen of Bell, Calif., on December 28. California Highway Patrol officers literally caught Gerritsen in the act as he made an illegal transmission in front of his small business.


In his possession was a tape recorder containing a cassette with the recording, "You Rampart pigs are a bunch of a\*\*\*\*s," along with other recordings that have plagued many amateur, GMRS, law enforcement, and media radio systems over several months. Several radios also were confiscated.

Gerritsen was arrested and booked at the Bell Police Department for violating California Penal Code Sections 636.5, prohibited interception of police radio communications, and 148(a)(2), interference with police radio communications. Gerritsen illegally interfered by transmitting on police frequencies on more

> than a hundred occasions. He "hit" 462.675, too, as well as local TV stations' remote pickup frequencies.

Gerritsen is currently out of jail on bond. Watch the REACT-L newsgroup

# **Board Calls for Nominations**

he RI Board of Directors is, according to Chairman B.J. (Frank) Jennings (Region 6), seeking nominations for three Regional Director positions. March 15, 2000, is the deadline for completed nominations to be received at the *REACT* International office in Suitland, Md. Each position is for a three-year term, beginning in July 2000.

The three regions are 1, 4, and 7. Current incumbents are Fred J. Lanshe (Region 1, from Pennsylvania), Jack E. Murrell (Region 4, from Indiana), and Lee W. Besing (Region 7, from Texas).

Region 1 consists of REACT Teams in Maine, Vermont, New Hampshire, Massachusetts, Connecticut, Rhode Island, New York, and Pennsylvania.

Region 4 Teams are Michigan, Indiana, and Ohio.

Teams in Region 7 are Arkansas, Louisiana, New Mexico, Colorado, Kansas, Missouri, Oklahoma, and Texas.

The REACT International Bylaws require that a Regional Director be a member in good standing of a Team within the region he/she represents. Additional requirements are that a Director must be at least 21 years of age, have been a member of any REACT Team for more than three years, and have demonstrated leadership experience at REACT Team and/or Council level, other non-profit corporations, or public agencies. (There is no requirement that a Director resign from other REACT Team, Council, or corporate offices.) Because of current budget

restrictions, it is expected that corporate officer and directors will continue to pay for most of their own expenses.

Candidates may be nominated by Teams, Councils, or individuals (including the candidate). Nomination forms are available for download from the REACT International Web site at < www.reactintl.org > or by mail from the REACT International office (must be requested by mail, fax, or telephone).

# How To Get Nomination Forms

The simplest and fastest way to obtain the nomination form for the Regional Director election is to visit the REACT Web site at < www.reactintl.org > . From the home page , click on the button for "downloads." This takes you to a page of documents that are available for downloading to your computer.

You must have the Adobe Acrobat Reader to read the documents. If you don't have the Reader, click on the button at the left of the screen. This will take you to the Adobe download site. You can download the Reader free.

After installing the Reader, return to the RI site and download the nomination form.

### CONVENTION UPDATE

Here are some Q&A's, covering some questions we've received, that may help everyone.

First, the URL for the Convention has changed. Please change your bookmarks and, if you have a Web site, change the link to the Convention Web Site. The new URLs are:

Q: Why should I register early instead of waiting until I get to the Convention?

A: Because you might miss out on some very important items. First: if your application is postmarked no later than March 15, 2000, you will be eligible for a drawing to get your \$60 registration fee refunded. (Not the extras, just the basic fee). On May 15th, the registration fee goes up to \$75.00. Another good reason is planning. Most hotels need to know in advance how many will be there for the breakfast or luncheon (they have to know how much food to buy, for instance), to be served in the meeting room. Remember, in Nebraska, the Life Members had to march down the hall to get their luncheon because the majority signed up at the convention! The Medical folks need to know in advance how many will take their medical classes. They need 20 in each to give us the \$15.00 rate for REACT as opposed to regular \$25.00 rate. The mobility scooters/wheelchairs are coming from 70 miles away, and they need to know how many to bring and of which type. The hotel holds the room blocks up to 2 weeks prior to the Convention, then they open them to any and all tourists. Remember, you won't only hurt yourself but you can affect other REACTers.

Q: Do I make reservations to Orlando or Kissimmee?

A: If you are coming by air, then book for the Orlando International Airport. If you are coming by train, then book for the Kissimmee train station. We are still working on solving the expensive bus ride (\$20.) from the airport and train station (a bit cheaper but not sure of the rate since it's only a few miles away). We'll keep you advised.

Q: I filled out an application in Nebraska. The one in the REACTer is different. Do I need to fill out a new one?

A: NO, as long as nothing changes. However, Page 2 (reverse) is new and if you want to sign up for the medical classes, or you need a wheelchair or mobility scooter, then just copy the second page and send that. Be sure to put your name on it!

Q: Do Junior REACTers or children need a separate application?

A: ONLY if they are participating in the Junior REACT/Children's Activities. Please put their age in the children's block. Fill out any blocks that apply to them. If they are not participating, then just include them in the children's block; show the number and ages.

Q: When are the rules for the contests coming out?

A: They will be published in the March-April Convention Special REACTer. In the meantime, get your newsletters, Web sites, scrap books, and brochures all "prettied up". Also get your ideas for a placard contest (one for Councils and Teams, and one for Junior REACTers)! You won't believe the type of awards you can win. There will also be awards for certain categories of REACTers just for showing up!

Q: I have a six-year-old who would like to participate in the Junior REACT activities. Is she old enough and would she have to pay the registration fee?

A: The Junior REACT and Children's activities are combined. Since a few of the activities and the Junior/Children's Banquet have a cost to them, all children must register to participate. The minimum age to participate has not been established yet. We have a volunteer to babysit the young ones during Convention hours for free. After hours, babysitters will be available on a fee basis.

# Federal City REACT

We had our radio room in the EMA Office up and running. We had a mobile and a foot patrol working on the Mall as eyes and ears looking for trouble and illegal behavior. Our units operated on both GMRS and BOOMHz to report incidents. At the D.C. EMA offices in the Reeves Center, our units monitored CB, GMRS, Amateur, MARS, and official channels for radio communications.

If Y2K trouble occurred, the Team would have come out to support additional communications.

### Florida REACT

Before: Florida's Emergency Operations Center (EOC) will activate to a level two (out of four) beginning at 6:00 a.m. Friday, Dec. 31, 1999. The limited activation of the EOC will allow the state's emergency management team to monitor the change of the millennium all across the world and continue to prepare Florida in the unlikely event of major problems caused by the Y2K

date-code bug.

"Florida is one of the best prepared states in the country," said Steve Seibert, Secretary of the Florida Department of Community Affairs.

Authorities at the Emergency Operation Center plan to update Floridians throughout the day on Dec. 31 and into the early hours of the New Year.

"We are prepared for Y2K in Florida because of the level of cooperation between the private and public sectors in the state," said Joe Myers, Director of the Florida Department of Community Affairs, Division of Emergency Management.

After: The Florida Council of RE-ACT Teams entered the Y2K rollover period on a hot standby. At ten p.m. on Dec. 31, the Florida Council went on level II alert across the state.

Some teams activated special radio nets for stand by. Other had extra CB 9 monitors on stand by. Space Coast REACT, along with Orlando Metro, Flagler County Assist, and Pinellas Pasco activated standby GMRS nets, and extra CB 9 monitors. Daytona Beach REACT also added monitors to cover CB 9.

Some teams also provided amateur radio support, working directly with ARES/RACES groups. Osceola County REACT even worked with hams from Walt Disney World. The two DCAT Teams were also on alert. Everglades DCAT was on level III assisting with EOC back up communica-

tions. Florida State DCAT patched into amateur radio nets in Indian River and St Lucie Counties, and also was on standby for deployment in the state should a need arise.

As midnight rolled through the state, the lights stayed on and communications systems continued to work. All Florida Teams were secured by seven a.m. on Jan. 1, 2000.
