<www.NationalSOS.com> have announced a bold initiative to supply Emergency Communication Kits with Family Radio Service / General Mobile Radio Service (FRS / GMRS) twoway radios to every family in America. The national distribution of the Emergency Communication Kits by REACT coincides with the U.S. Department of Homeland Security's "National Preparedness Month."

Each Kit includes a Midland 22-channel FRS / GMRS two-way radio, radio operations tutorial, and a "1-2-3 Emergency Communication Guide." In a hurricane, flood, tornado, earthquake, or manmade disaster --or for individuals lost in the woods or stranded in automobiles due to severe weather, these Kits could be a supplemental lifeline to emergency assistance.

The cost of these Emergency Communication Kits is subsidized by *REACT* and the National SOS Radio Network. The delivered price per Kit is only \$10.99. Your Kits are available by sending a check or money order payable to *REACT* to PO Box 395, Corona, CA 92878. We are also working with a merchant provider to accept future credit card orders for your Kits and are expected to be ready very soon.

Since 1962, *REACT* has led major efforts in emergency communications and disasterpreparedness programs. Your EVP said, "We are proud to offer these Kits at our raw outthe-door cost. Our goal is to give every person in America the opportunity to have an active role in emergency-rescue operations should a dire circumstance arise. I encourage every *REACT* member to obtain a Kit and promote the program in their local community."

Eric Knight, founder of the National SOS Radio Network, said, "With proper training, these radios can be a valuable neighborhood-communications tool when traditional telephone and cell phone services fail. We endorse the neighborhood-communications plans as published at:

In conjunction with this effort, *REACT* and the National SOS Radio Network are distributing to the media PSA radio spots and scripts to educate the public on their 1-2-3 emergency communication plan. Listen to 1-2-3 PSA announcement:

short, if someone is trapped in their home or lost (such as in their car or woods) without a working cell phone, at the top of every hour he or she should call on the radio's Channel 1 for 2 minutes and listen for 3 minutes -- hence "1-2-3." REACT and the National SOS Radio Network are encouraging local, state, and national emergency-rescue resources to monitor Channel 1.

In a REAL Emergency, follow these 3 steps:

- Turn on your FRS radio to Channel 1. Broadcast every hour ON the hour with privacy tones turned OFF. Say your name, exact location, and the nature of the emergency.
- 2) Keep calling for 2 minutes. For example, "Emergency! This is John Smith. I am 12 miles South of Interstate 95 on Route 7. My car won't start. Please send help."
- 3) Listen for 3 minutes for an answer. If you don't hear one, save your batteries by turning off the radio and wait until the top of the next hour to call again.

It's as easy as "1-2-3." Call on Channel **ONE** every hour. Talk for **TWO** minutes. Listen for **THREE** minutes.

A VISIT TO THE WHITE **HOUSE**

On a sunny Monday afternoon, September 8, 2008, I was given the opportunity to represent REACT International by attending a ceremony for volunteer organizations at The United States White House. We were invited primarily because of our membership with National Voluntary Organizations Active in Disaster (NVOAD). REACT is proud to be one of the 31 national member organizations supporting NVOAD in its worthwhile efforts (See more information at: <www.REACTintl.org>).



While awaiting the President's arrival I had the opportunity to meet and visit with the leadership of other volunteer organizations from around the country, and was able to form networking contacts that should be helpful to REACT International in the future.

Did I get to see the President?

Yes, I did, and it was terrific. Our assigned seat was near the center front (third row from the front. fourth seat from the center aisle). You can see the back of my head in some of the media photographs. See me in the bottom left corner of the photo below (photo courtesy of USA Freedom Corps photo by M. T. Harmon).



What Did President Bush Say?

The President spoke on the White House south lawn to a crowd of 1,800 people that included members of Congress, three cabinet secretaries, members of the President's Council on Service and Civic Participation and the Corporation for National and Community Service board, state service commission directors, corporate social responsibility executives, and leaders and volunteers from Senior Corps, AmeriCorps, Learn and Serve America, Citizen Corps, the Peace Corps, and Volunteers for Prosperity... and of course, REACT International.

"Volunteerism is strong in the country. But the truth of the matter is, the farther we've gotten away from 9/11, that memory has begun to fade," President Bush said. "And my call to people is, there's always a need. You should be volunteering not because of 9/11, but you should be volunteering because our country needs you on a regular basis. And so today I call upon our fellow citizens to devote 4,000 hours over your lifetime in service

to your country. You'll become a better person for it, and our society will be more healthy as a result of it."

The event looked at the advances in citizen service achieved over the past seven years and forward at the opportunity to grow service and volunteering in the future. The President recalled his inaugural address, where he asked Americans to be "citizens, not spectators; citizens, not subjects; responsible citizens, building communities of service and a nation of character." He concluded by saying "I am incredibly optimistic about the future of our country. And the reason I am is because I've seen firsthand the love and the compassion and the decency of our fellow citizens."

Did I personally get to talk one on one with the President?

No I did not, however the way security kept him on the move I did not observe anyone that got too close to him, other than a 3-star General from the Civil Air Patrol. I did get to be within five feet of him for a very short time, before he was moved on to the other side of the seating section.

Toward the event's conclusion, as we stood in yet one more line waiting to be let into the East Wing of the White House, I did make another brief sighting of the President from about 10 feet away.

We were being escorted out the front of the building to the Northeast Gate when that encounter happened.

I left the ceremony that day, proud that *REACT* International had been chosen to participate, and glad that I was able to represent all the other *REACT* members at this event.

Navy – Marine Corps MARS Signs MOU with *REACT* Teams in Texas

Press Release By Lee Besing, N5NTG and Bob Hejl, W2IK / NNN0GBY2 In Texas, while it is obviously hurricane season right now, apparently it is also the season for cooperation between various radio communications agencies as well. On August 18, 2008, Charles

Land, president of the local San Antonio based Hill Country *REACT* Team, signed a Memorandum of Understanding (MOU) with the South Texas Navy – Marine Corps MARS (Military Affiliated Radio System). Minutes later,

Texas State *REACT* Council Secretary, Lee Besing, signed a similar agreement with the Texas Navy – Marine Corps MARS.

This agreement was initiated by local MARS operator Bob Hejl, and supported by the MARS officers above him in their chain of command. Bob contacted *REACT* to ask if they would be willing to sign such an agreement, and the rest is history. Ironically, the signing took place during REACT's monthly meeting at the Bulverde Volunteer Fire Department, where the sign on the wall behind them said "Don't train till you get it right, train until you don't get it wrong."

By signing this agreement, it opens the doors to joint operations, and sharing of equipas the radio ment such equipped communications trailer operated by the *REACT* Team, or the many other resources provided by MARS. The wording of both agreements were similar, and basically provide a mechanism by which the two emergency radio organizations will utilize so that they can better communicate with each other prior, during, and after, emergency operations. To characterize one member's summary, he

said "we've agreed to play nice with each other and talk to each other." The agreement does not commit either organization to specific actions, but does create a framework to encourage communications between the local REACT Teams and local MARS units.

Texas State REACT Council Lee Besing was quoted as saying "We plan to use this MOU as a basis for approaching other Ham Radio emergency agencies in Texas to establish similar agreements with them and will be asking **REACT** International's board of directors to open similar talks with MARS as well on a

Both groups are comprised of volunteer radio operators, normally licensed Amateur Radio operators (also referred to Ham Radio operators or Hams), who have agreed to use their two-way radio skills to help their communities in time of need, or in the case of RE-ACT; also for public service events. There are nearly two dozen organizations in the San Antonio and Central Texas area who utilize Ham Radio in their missions. The Military Affiliate Radio System (MARS) is a Department of Defense sponsored program, established as separately managed and operated programs by the Army, Navy-Marine Corps and Air Force. MARS members are

volunteer licensed amateur radio operators who are interested in providing auxiliary or emergency communications to local, national and international emergency and safety organizations, as an adjunct to normal communications. Last month in late July, a Navy -Marine Corps MARS unit in the south Texas Rio Grande Valley was very instrumental during Hurricane Dolly when 6 out of 10 key Ham Radio voice type repeater towers in that area were knocked off the air by the storm and loss of power. The MARS unit (Ray -NNN0VHO) stationed down at Harlingen was able to maintain radio communications through out Hurricane Dolly and send messages via HF digital modes on Ham Radio up Bob Heil's station, and then Bob relayed them to Amateur Radio Operators located in the San Antonio Emergency Operation Center (manned by another ham organization called ARES) and to the Texas State EOC up in Austin, Texas, Information in the reports included such facts as updated info about local area flooding of major streets and highways, damage to structures and infrastructures, availability of emergency vehicles to respond to calls during the storm, and weather reports as the hurricane passed through his area.

REACT Teams are independently organized groups of radio operators using multiple modes of communications, including Amateur Radio, FRS & GMRS radio, and in some areas of the country,

CB radio. REACT Teams are known for working public service events and playing a supporting role to other agencies and organizations, such as the Bexar County ARES who provides the primary manpower for the local American Red Cross and the San Antonio EOC. REACT Teams are only chartered thru REACT International, Inc. <www.reactintl.org>, which provides for their 501(c) 3 non-profit status and liability insurance coverage. REACT's stated mission as listed on their website is as follows: "We will provide public service communications to individuals, organizations, and government agencies to save lives, prevent injuries, and give assistance and wherever whenever needed. We will strive to establish a monitoring network of trained volunteer citizenbased communicators using any and all available means to deliver the message."

The following is an extract from the statewide agreement MOU, which is likely to be used a basis for establishing a nationwide agreement in the near future. The local MOU was worded very similar in nature, focused on Central and South Texas operations.

PURPOSE

1. This purpose of this document is to state the terms of a mutual agreement (Memorandum of Understanding) between Texas State *REACT* Council (Radio Emergency Associated Communication Teams) and Texas Navy-

Marine Corps MARS (Military Affiliate Radio System), that will serve as a framework within which both organizations may coordinate the development of protocols and procedures for communication in emergency and disaster situations. Each organization comprises volunteers and professional staff in support of their respective educational and technical programs and efforts. It is intended that this agreement will promote joint coordination and exercise of the resources of both Texas State REACT Council and Navy-Marine MARS to recognize the potential and capability of individual members of both organizations to facilitate the flow of information to and from the public during disaster and emergency situations.

RECOGNITION

- 2. Texas State *REACT* Council recognizes Texas Navy-Marine Corps MARS as a service of radio operators affiliated with Military Affiliate Radio System, organized in the interest of military radio communications for the benefit of exchanging information with, but not limited to, Military systems, FEMA, DHS and other governmental agencies. MARS was organized for the establishment of networks to provide communications in the event of disasters or other emergencies.
- 3. Texas Navy-Marine Corps MARS recognizes Texas State *REACT* as a public service or-

ganization of private radio operators, which provides radio communications to local communities during emergencies. The Texas State *REACT* Council coordinates and encourages its local Teams to cooperate in efforts with other emergency organizations including the police, FEMA, NOAA. RACES. ARES. NVOAD, the Salvation Army, and the American Red Cross. Texas State REACT 's local Teams engage in other activities include participation in safety radio assistance for community events, and developing the use of radio services as additional sources of communications in emergencies. Texas State *REACT*''s primary mission is to support local Teams who will improve their communities through the provision of voluntary, two-way communications that serve the interests of public safety.

PRINCIPLES OF COOPERATION

- 4. In order that the parties may cooperate and utilize their resources from time to time to optimum mutual benefit to both parties, the following principles and methods are agreed upon:
- 4.1 The parties will correspond with each other and exchange certain materials and engage in certain activities in order to encourage and broaden interest, understanding, and appreciation of radio telecommunications technology and its value to the public in emergency situation.

- 4.2 The parties will work to establish protocols and procedures that foster safe and efficient radio services communication to help the public during emergencies and disaster relief. The parties, through these protocols and procedures, will try to eliminate duplicative or technically inferior service to the community in emergencies.
- 4.3 The parties will work with each other in times of emergency or disaster to meet the communications needs of the public.
- 4.4 The parties will generally encourage ongoing liaison with each other and urge members of both organizations to develop increasingly effective communications and cooperation.

SKYWARN IN CLEVELAND COUNTY, NORTH CAROLINA

On July 7 and 8, Cleveland County *REACT* in Shelby, North Carolina put up the SKYWARN net because of tornado warnings. On the seventh, Chief Jay Flora patrolled looking for funnel and wall clouds.



He observed the storm hitting Lawndale and Fallston. The storm also hit east of Cleveland County causing significant damage. Assistant Chief Spencer Jones monitored radios.



On the eighth patrol continued with Flora and Jones carrying out duties. The storm downed trees and power lines all over the county and neighboring counties. Jay Flora was there to help direct traffic watch houses of absent officials, and report to the National Weather Service. J

The Central Indiana *REACT*-CERT Team came to be quite literally in a whirlwind; the evening of May 30th of 2008 saw Indiana being pounded by Thunder Storms and Tornadoes, with the members of Team 6137 square in the middle of the action.

It had all started a couple of months earlier when several of us had begun talking about how we should start a *REACT* Team in central Indiana. A Team that would monitor Citizen Band (CB) radio, work with the different county emergency management agencies, do disaster work and work with nongovernmental agencies involved with disasters, as well as working with the various Amateur Radio groups in the area.



We processed our paperwork, filed of incorporation papers, and filed out Team charter with *REACT* International all during *REACT* Month. We wanted everything to be in place when we held out first meeting.

Then two days before our startup meeting we got the stark reminder that we live in Indiana. Our Saturday May 31st meeting had to be changed to a day later because several of our new Team members were aggressively working at disaster sites in Central Indiana.



With nine people present we held our formational meeting, temporary officers were elected, start-up by-laws voted on, and our existence formalized. Then it was back out the door to assist the public we had just reaffirmed our aspiration to help.



In the three months that have followed that assembly, we have increased our membership to fifteen Regular, five Probationary, and four Honorary members, held two training classes, three general business meetings, hosted five ICS classes, established contacts with various ESF groups or non-governmental agencies, discussed MOUs and MAAs with other agencies, and set up our web page <www.reactindiana.org> not to mention assisting four motorist and making reports of infrastructure or traffic control device problems.

Hospital Drill

On June 26 Paul Munns and Paul Oby of Ramsey County *REACT* in St. Paul, Minnesota, as well as a representative from the Minnesota Association of Emergency Managers, many doctors, nurses and other hospital staff assisted in a hospital drill. *REACT* provided ham radio communications between 7 locations in the Twin Cities area that are staffed by other hams.

The scenario was a major terrorist attack on a downtown high rise office bldg involving 500 people with numerous injuries. This drill was to ensure that everyone could communicate with each other in an emergency if the phones were down – and we did.

Two 2 meter repeaters and one simplex frequency were used with great success.

It is planned that by the end of this year every Minnesota and Wisconsin – at least western – hospital will have a ham station in it and operators available at any given time.

To support this goal the Veteran's Hospital in Minneapolis holds two ham license classes every year and has a large turnout.

Parade

On July 4th Paul Munns, Brian Flaherty and Paul Oby provided ham radio communications for the 4th of July Afton, Minnesota, parade. Afton is a small river town about 25 miles east of St Paul.

This was the first time the parade has used hams, and things went so well that the Mayor and parade officials want us back next year and they may contact us for other events as well.

In the monthly newsletter that the city of Afton sends to all its residents, Mayor Julia Welter says "I would like to thank members of Ramsey County *REACT* for volunteering to help walk the parade route to ensure safety. Their willingness to assist is very much appreciated."


