Welcome all *REACT*ers to 2012.

This new year *REACT*ers are anticipating many things, including the 50th Anniversary of *REACT* and the potential for a convention. As previously reported, due to unforeseen circumstances, the chosen host for the 50th Anniversary Convention withdrew its support for the event. This has brought many of you great worry about this significant event.

At this time, the Board of Directors is yet to see any proposal from any team to host this historic event. While I as well as the board share in the members distress over the lack of a convention, no team or council has stepped up to the challenge to host this event. We have had many individuals offer their assistance to a potential organizer, but no potential host has come forward. With no team or council stepping forward, **RE-ACT** International cannot step up and save the 50th Anniversary Convention, only you the members and their respective Teams and Councils can do that.

If you want an convention, then get together with other Teams or Councils and get an event plan to the board of directors soon or it will be too late to act and there will be no anniversary celebration as one member has put it.

About the President

John is the serving Director of Region 8 and was recently appointed to fill the unexpired term of President of REACT International.

He is also President of LacoREACT in Los Angeles, California.

On to annual renewal updates, as of the writing of this article, 59 of 155 Teams or 39% of the Teams have renewed. Of the total members 567 of 607 or 93% Members that are part of those teams have renewed for the upcoming year. We have yet to receive 61% of the Team Renewals yet for 2012. Remember that 2012 renewals sent in after January 31st, 2012 is considered late. Any renewal sent in after that time should include a \$10 late fee.

Remember also that per *REACT* International Policy, any team that is not renewed by February 29th, 2012 is no longer considered a Team by *REACT* International. You may still and are encouraged to renew after that time, but a \$20 late fee should be included with your renewal package if sent in after March 1st, 2012.

REACT members donate thousands of hours of

supplementary auxiliary communications in civil emergencies, emergency management drills and charity public service events such as parades and marathons each year. Such events show **REACT** in its best light, and it is critically important that **REACT** International bring documentation of this work to the attention of the Congress, the FCC and other public officials. Your local information is an important addition to the *REACT* record.

I know that the monitoring report is a huge burden every year during renewal, especially if our record keeping leaves something to be desired. It just seems to take forever and some really don't want to deal with it. I have heard of teams who just make up their monitoring report and finally, not all teams actually return these forms to **REACT** Headquarters.

So what good is this information? Grants for one thing; my local director is always using the fact that volunteers save City Government money and the community in services that would normally cost them something before getting a commitment. This reminder helps when looking for training and grant money.

Volunteers pitch in where needed most

FLAGLER BEACH — Festivals, walkathons, footraces and parades generally come off without a hitch in Flagler County, in part because a dedicated group of volunteers help law enforcement with parking and traffic control.

Flagler County Assist *REACT* community public service volunteers — 30 of them — logged 1,462 collective hours this year, and that was before the Dec. 3 Christmas parade in Flagler Beach.

"Affect traffic control at this time, per Chief (Dan) Cody," called out Eric Pickering, operations officer, through his handheld radio that is part of the general mobile radio service for the county.

Well before the parade started, Pickering and seven other volunteers had a meeting to discuss how best to man critical intersections so 16 police officers and six fire police officers could address larger issues.

"This is a great help to us," Cody said before briefing Pickering. "On the Fourth of July, we had some kids get lost, and they were able to just saturate the area."

Flagler County Assist *REACT* was organized in 1985 and is part of the 50-year-old international *REACT*, which stands for Radio Emergency Associated Communications Team. It has assisted with the Flagler Beach parade every year since the first one in 1988, said Bob Pickering, president.

The group of volunteers, each using a designated number rather than a name, communicated through their radios throughout the event to keep traffic off State Road A1A for the safety of the residents there to watch the parade and the participants alike.

"Post 1 to all listening units, until the parade passes State Road 100, we're supposed to maintain traffic control," the operations officer instructed.

Howard Pepper, a member with six years of service who is also a ham radio operator, said it's important to protect the detour route so traffic keeps flowing.

"We have a plan and this is how we avoid problems," he said.

Palm Coast resident Irene Pickering, who is also a founding member, gave her sons a set of CB radios in 1985 while Bob was still in high school and Eric was in middle school, and Flagler County Assist *REACT* began shortly after that.

"They were helping people during the wildfires," she said. "I don't think people realize how much we help the communications during emergencies."



Eric Pickering manned "the base station" at home while his brother and two friends were at the one and only shopping center at the time, relaying information about the fires dispatched from home.

Besides the Pickerings and longtime member Richard Frazier, membership has turned over twice. Frazier, a retired railroad conductor, said the organizations function has changed over the years.

"We used to help out more with search-and-rescue and even had a search-and-rescue team," he said.

Bob Pickering said where technological innovations and the county's purchase of a helicopter have nearly eliminated some of the groups' functions, budget cuts have increased the need for volunteers in other areas.

"We work more public events than ever before," he said. Maryann Norvik, the newest member, joined in August and a day or two later helped out during the funeral of Flagler County Sheriff's Sgt. Frank Celico.

"I was nervous," Norvik said. "They didn't give me a lot of responsibility, but I delivered water to other REACT members and deputies."

She said the group was very welcoming.

"We're a great group if you want to volunteer to help people," said Madeline Pepper, *REACT* vice president.

"We have a lot of fun. It's not about politics. We're just people helping people."

s 2011 comes to a close, we reflect on the events of the past year.

2011 brought nearly every type natural disaster known to man. In February, a major blizzard that dumped over one foot of snow on the metro. COR units were out in full force to aid stranded motorists and render other aid when needed.

We even had a record breaking 5.6 Earthquake, then a Quakenado.

We had floods throughout parts of the metro. In May, an outbreak of tornadoes claimed lives and was the catalyst for COR to begin the process of creating a search and rescue team. COR started a newsletter to keep people better informed of who we are and what we do. We had our share of tragedy also. We lost many people important to our members. Parents, aunts, uncles, nephews, family friends and a son of a member, which was a young man with a goal to be a General.

COR reached out to new areas and gained national attention with an internet interview.

2011 is over, and the COR team was glad we were able to help so many. Here is to a better 2012, full of growth, and by the grace of God, less tragedy.

REACT International Director Seats up for Election

Hello, fellow *REACT*ers. it is again time to elect a

Director to represent your region as a member of the REACT International Board of Directors. The Region 1, Region 4, and Region 7 Director seats are now up for election.

Are you happy with your Director's performance? Has (s)he been attentive to your Region's needs, working diligently to assist your Team's needs, or to resolve your concerns with the best interests of the program in mind?

Directors are responsible for the management of the property, business, and affairs of the corporation. The Directors may exercise all powers of the corporation as are not by law, or by the Articles of Incorporation, or by the **REACT** International Bylaws, "directed or required to be executed by the Member Teams."

How many times have we heard some Directors state that they have nothing to do with the Teams? Teams in regions one, four and seven have the opportunity to remind their Directors who they should be serving by electing a new Director, if they so choose, to represent and work with you, the Member Teams, in their regions towards bringing the program into the 21st century.

You, the Member Teams in Regions 1, 4, and 7 have the power to bring nominees for the Director seat to replace that Director who you may feel may not have been there for your region, who you may never have heard from in those times you may have needed to.

The **REACT** International program should serve the Member Teams by providing the tools, training, and support to maintain a presence in the auxiliary communications industry, bridging the gap between the citizen based response teams with government organizations, and educating the general public in use of the multiple Citizens Radio Service during times or emergency and disasters. Is your Director working towards these and other goals that Member Teams expect of our Board of Directors?

REACT International Bylaws Section 5.3 Nomination and Election of Directors provides that (a) Candidates for Director may be nominated by Teams, Councils, or individuals (including the candidate). (b) Elections shall be conducted by REACT International by mail ballot of Teams, in accordance with rules and procedures established by the Board of Directors. (Subparagraph (c) pertains to election of "Outside Directors.")

Nominations must be received by March 15, 2012. The ballots will go out to the Teams in April for the election of your Director who will be seated in July.

Directors and officers serve in a fiduciary capacity because they hold the assets of their organization in trust. While some volunteers treat these responsibilities lightly, a lapse in responsible behavior can bring serious charges and possibly personal liability.

Thus, Directors and Officers should take special precaution to three basic areas of fiduciary responsibility.

Duty of Care and Diligence

A Director or officer must exercise a duty of care and diligence and to give informed and prudent attention to all affairs. Directors therefore have a duty to be informed, which requires Directors to attend most if not all meetings and to be informed of decisions made at meetings that they were unable to attend. Directors should also review the financial and non-financial results and operations of the organization on a regular and ongoing basis.

Directors and Officers should beware of the following: mismanaging or wasting corporate financial assets; negligent maintenance of corporate property; the following: mismanaging or wasting corporate financial assets; negligent maintenance of corporate property; negligent supervision of charitable services; publication of slanderous or libelous statements; failure to withhold or collect or remit taxes; wrongful treatment of employees; defaulting on commercial contracts; improperly distributing corporate assets upon dissolution; making improper loans to corporate Directors or officers; and failure to exercise responsible financial management.

The Duty of Loyalty

This requires honesty, good faith, fairness, and avoidance of conflicts of interest (described in detail in

Question Four above).

The Duty of Obedience

Directors and officers comply with a duty of obedience to the organization's purposes, bylaws, and other official policies. Thankfully most of these items may be considered a matter of common sense. Every charitable organization must allow members of the public to inspect its 1023 application, the supporting documents, and any letter or document issued by the IRS in connection with the 1023 application. In addition, the public must be able to inspect the organization's annual IRS Form 990 returns for the last three years. If someone requests a copy by mail, you must provide a copy of the requested documents by return mail but may charge a small fee for your copying and mailing expenses.

Any Director being considered for a seat on the Board of Directors should be prepared to perform the duties and see that this any all other matters of the corporation are responsibly fulfilled.
