




Positive comments were received from the organizers indicating that *REACT* provided much valuable communications assistance on the day.





#### Mid-April to Late August is Tornado Season in much of the Country. Here is some information from the <u>National Weather Service</u>

#### What

A tornado is a violently rotating column of air that extends from a thunderstorm to the ground and is often—although not always—visible as a funnel cloud. Lightning and hail are common in thunderstorms that produce tornadoes. Tornadoes cause extensive damage to structures and disrupt transportation, power, water, gas, communications, and other services in its direct path and in neighboring areas. Related thunderstorms can cause heavy rains, flash flooding, and hail

#### Where



About 1,200 tornadoes hit the United States every year and every state is at risk. Most tornadoes in the United States occur east of the Rocky Mountains with concentrations in the central and southern plains, the Gulf Coast and Florida.

#### When

Tornadoes can strike in any season, but occur most often in the spring and summer months. They can occur at all hours of the day and night, but are most likely to occur between 3 p.m. and 9 p.m.

#### **Before a Tornado**

• Identify safe rooms built to FEMA criteria or

ICC500 storm shelters or other potential protective locations in sturdy buildings near your home, work, and other locations you frequent so you have a plan for where you will go quickly for safety when there is a Warning or an approaching tornado.

- For schools, malls, and other buildings with long-span roofs or open space plans, or many occupants, ask the building manager to identify the best available refuge.
- Build an emergency kit and make a family communications plan.
- Listen to NOAA Weather Radio or to commercial radio or television newscasts for the latest information. In any emergency, always listen to the instructions given by local emergency management officials.
- Be alert to changing weather conditions. Look for approaching storms.

Look for the following danger signs: Dark, often greenish sky Large hail A large, dark, low-lying cloud (particularly if rotating) Loud roar, similar to a freight train.

#### If you see approaching storms or any of the danger signs, be prepared to take shelter immediately. Know the Terms

Familiarize yourself with these terms to help identify a tornado hazard:

**Tornado Watch** - Tornadoes are possible. When there is a Watch, move to be near enough to a shelter or sturdy building to be able to get there quickly in a few minutes if there is a Warning or if you see signs of a tornado approaching. Remain alert for approaching storms. Watch the sky and stay tuned to NOAA Weather Radio, commercial radio or television for information.

Tornado Warning - A tornado has been sighted or indicated by weather radar. Take shelter immediately.

#### **During a Tornado**

If you are under a tornado warning, seek shelter immediately! Most injuries associated with high winds are from flying debris, so remember to protect your head.

### If you are in school, nursing home, hospital, factory, shopping center, high-rise building pre-identified best available refuge then:

Go to a pre-designated area such as a safe room built to FEMA criteria, or a small interior windowless room



on the lowest level, below ground in a basement, or storm cellar, is best. (closet, interior hallway) away from corners, windows, doors, and outside walls. Put as many walls as possible between you and the outside. Get under a sturdy table and cover your head and neck with your arms and cover your body as best you can e.g., with a heavy coat or blankets, pillows.

- In a high-rise building, go to a small interior room or hallway on the lowest floor possible.
- Do not open windows.
- A sturdy structure (e.g. residence, small building), school, nursing home, hospital, factory, shopping center, high-rise building)

#### A manufactured home or office then:

Get out immediately and go to a pre-identified location such as the lowest floor of a sturdy, nearby building or a storm shelter. Mobile homes, even if tied down, do not offer protection from tornadoes.

#### The outside with no shelter then:

If you are not in a sturdy building, there is no single research-based recommendation for what last-resort action to take because many factors can affect your decision. Possible actions include:

- Immediately get into a vehicle, buckle your seat belt and try to drive to the closest sturdy shelter. If your vehicle is hit by flying debris while you are driving, pull over and park.
- Take co ver in a stationary vehicle. Put the seat belt on and cover your head with your arms and a blanket, coat or other cushion if possible.
- In all situations:
- Do not get under an overpass or bridge. You are safer in a low, flat location.
- Never try to outrun a tornado in urban or congested areas in a car or truck. Instead, leave the vehicle immediately for protection in a sturdy building.
- Outdoor areas are not protected from flying debris. Flying debris from tornadoes causes most fatalities and injuries.

Whereas *REACT* members give willingly and voluntarily of their time, and effort, often using their own equipment and money to accomplish their goals, and;

Whereas There are nine *REACT* Teams in North Carolina; (Substitute your State Name and number of Teams or City Name for this line)

**Therefore** It is hereby proclaimed that the month of May in the year Two Thousand and Eighteen shall be declared to be National *REACT* Month in order to recognize, celebrate and honor *REACT* members nationwide.

Also - see if a local business in your town might consider throwing a little event celebrating your team - Can't hurt to ask!

## **Guest Editorial**

For the past year or so, we've noticed an uptick in activity by the Federal Communications Commission going after illegal operators, especially those causing interference.

The thing that strikes us odd the most is the FCC isn't tiptoeing around the illegal operations, no matter who is causing them. We've seen notices issued to states and even towns for illegal operations. Nobody is spared by the FCC's enforcement arm.

From what we're seeing, if you're operating illegally on a frequency without a license or causing interference on any frequency, the FCC will hunt you down, cite you and carry out a large fine as the penalty, too. You might even go to jail.

We've especially seen an increase in the number of FM pirates who have been cited by the FCC in communities across the country. There seems to be a hotbed of pirates in southern Florida and the Boston area who have incurred the FCC's wrath. Some of those who have been cited by the FCC have had devices on the air that have knocked out legal users, such as cellular systems. There is no spectrum unnoticed by FCC agents across the country.

Even with fewer agents than ever before, the FCC seems to be knocking on more doors now and shutting down illicit operations. Today, there is a plethora of equipment available for purchase, especially as imports, that transmit almost anywhere you might want on the radio spectrum. Want to set up your own pirate FM station? You can do it for under \$100 with a signal that can cover a small town.

Want to interfere with public safety channels on VHF or UHF? Go buy a \$25 import handheld radio and program it and cause a ruckus that surely will land you behind the gray bars. It makes no sense whatsoever. Some of the highest fines ever have been levied by the FCC against those causing harm to radio systems that possibly could injure or cause death to those unable to use their radios in the course of their duties.

The FCC is evolving. The new FCC is making inroads to changing and removing many archaic rules to alleviate the burden on licensees and users. Last year's rewrite of Part 95 as it pertains primarily to CB, GMRS and FRS operations is a shining example. CBers now can shoot skip (hey, it's there, why fight it!) and FRS now has access to



GMRS channels without the need for a license, with an increase in power, too. We'll be seeing many more changes from this new FCC.

The thing to keep in mind is not to be stupid and ignore FCC rules. All it takes is one complaint and if it

falls on not-so-deaf ears at the FCC, you can expect agents and their direction-finding gear will be cruising your neighborhood to find you, shut you down and eventually fine you.

With that said, the FCC specifically said in their Part 95 rewrite that digital mode operations on FRS and GMRS channels is forbidden. Some have ignored this. But those high-power DMR repeaters on GMRS channels now may come to and end as the new rules explicitly forbid such operation. All we're saying, is be careful out there!

## From The Corner of the Room

Greetings all!

Well, it's May and it's still cold and rainy. Lots of rain but rain can be a good thing.

In our weekly *REACT* team practice nets we simplex between each station with our trusty copper J-Pole antennas and we have kept records over the years on weather. When it has rained and the ground is wet it greatly increases our signals and the quality of the audio increases as well. The fall and winter is also great for communications when the trees are bare; the leaves on the trees act as a blocker for radio signals.

Pine trees are the worst; the the resin in needles acts like a lead wall, so when you set up your base antennas, stay away from the pine trees. That resin is also why lightning strikes pine trees more than others because of the ground potential root to the system with the resin.



Remember the old CB trick you would let your garden hose run by the base of your

antenna for an hour and you had a better ground and when the skip was rolling you were in the game. The big misconception is people think "more power, more power", but the antenna and proper positioning is a primary factor.


If you have a sorry antenna you can run power and still talk a few miles but with a good antenna and with the proper SWR at the lowest setting possible and of course good low loss coax you would be surprised.

Power is a last resort. Remember stay in the FCC guidelines on the frequency that you are qualified to use. I heard that the Technicians (class) might get to be on more HF bands 80 and 40 and 20 meters. There is a request signed and being put before the FCC to give Techs a little more usable frequencies. I can't wait! Ten meter HF is great when the band is open but 20 and 40 meters always rock.

Keep sending in those pics to the *REACT*er so your team can be featured in the monthly publication! And if you have not been to a storm spotter class yet, shame on you! It's easy and it's fun! Contact your closest national Weather Service office.

**SUCCESSFUL MESSAGE RUNS:** The following members submitted 100% good copy for the April Message Run:

Keith McDonald (6247) - 10 words per minute Rusty Hemenway (6247) - 15 words per minute

The Message Run is an excellent way to validate your ability to copy the types of formal messages that you will encounter in disasters. We conduct immediately following runs the first *REACT*/Traffic System net (Wednesday at approximately 2130 EDT) of the month and during the second Saturday Zello Worldwide *REACT* Net after 2100 EDT. May's run will be a high speed run at reading speed, approximately 100 words per minute – you are allowed to record the run and listen to it once to fill in anything you missed on the on-air transmission.

**IN WORK** *REACT* **COURSES:** Two new *REACT* courses are in draft form, expected to be published in May:

*Citizens Band Radio Service* – covers basic theory of radio as it applies to the CBRS, the new regulations, and ways in which CB can be a part of an effective Team emergency communications program. This course supports Type IV positional qualification.

*Introduction to Net Control* – a detailed coverage of the mechanics of running a net, whether a formal traffic net or a disaster tactical net. This course supports Type III positional qualification.

**ALERTEX 2018-B:** The training package is out for ALERTEX 2018-B, a hurricane exercise. the dates are 23-24 May for basic scenario buildup, 25 May (Friday) evening for impact, and 26 May (Saturday) for the response phase. If your team has not yet accessed the training package at:

please do so today and make sure that your members have had an opportunity to review the contents. The packet includes information on hurricanes and on the format for a Team emergency operations plan. This exercise is designed to test elements of Team emergency plans. The scenario will include East Coast, Gulf Coast, Caribbean, and West Coast hurricanes. We are planning for significant reporting play from Teams to Radio Relay International for simulated forwarding to federal authorities. Expect the detailed exercise instructions the first week in May.

**COORDINATION WITH RADIO RELAY INTERNATIONAL** – In April your team received an e-mail from Radio Relay International, an international amateur radio traffic system, asking for local contacts. If your Team has not responded please do so now. RRI is working with *REACT* to expand our ability to communicate in disasters and to coordinate response activity. They provide us a reliable and fast way to pass emergency messages and reports out of and into your local area in the case of major communications outages. *REACT* TRAFFIC SYSTEM – To support our own message traffic system we need two types of people: (1) members who are interested in working with formal emergency messages in a highly disciplined net environment and (2) members who are interested in staffing an incident management team to gather information and reports and provide those to *REACT's* leadership to help us work with the national organizations with which we have memorandums of agreement. And we need members to work in these roles this coming hurricane season. Prior experience is not required, but a willingness to train and work hard at a high standard when bad things happen is. If you are interested contact Training@*REACT*intl.org as soon as possible

### Why Can't I Copy and Paste from The *REACT*er??

The simple answer is that the way the *REACT*er is posted for reading, in order to conserve server space, it has to be posted as an image rather than as a text file. The image file is around 4 megs in size whereas a text (or magazine) file would come in at around 200-300 megs.

It is unfortunately a fact of life that server space is expensive so we must conserve where we can. I am currently researching methods of posting to see if there is a way to at least post the current issue as a text file and then convert it to an image when it goes to Past Issues.

I will keep you posted.

On a different but somewhat related topic, for a while there, the 'l' and 'I' letters, plus '1"s were coming out looking like they were in bold when the rest of the word or number was not. I honestly do not know what was causing that so I came up with a work around. All type in The *REACT*er is now a 'serif' type (like New Times Roman). This eliminates the problem with the inadvertent bolding of straight line letters and numbers.

Our quarterly exercise schedule is in place for 2018, with ALERTEX 2018-A, a tornado scenario, scheduled for 22-23 February. Subsequent exercises are schedule for May, August, and November. Our focus this year is on Training Type IV deployable Communications Teams, Base Station Teams, and Message Teams to provide a range of capabilities in major emergencies and disasters. Training requirements have been established for individual members of Type IV Teams, and our objective is to start credentialing individuals and Teams at the end of April. To improve message

handling skills we now have an active weekly Traffic Net on Zello and are working to develop a core of operators experienced in traffic net operations. We have introduced a monthly qualifying run for formal messages that operates much as does the ARRL's code runs, and we have qualified operators at both 10 and 15 word per minute 100% good copy. Finally, we continue to support The *REACT*er with current information in a monthly training column.

Communications Committee Chair Mr. Mahon reported: Mr. Mahon spoke about the draft submitted for use of the WQUS415 Corporate Interoperability Channels by chartered Teams in good standing. The Memorandum of Understanding under the REACT International license two-way radio frequencies are intended by the FCC to be temporary means of communications with US Government stations "in connection with mutual activities." The DHS developed Post 911 interoperability channels to allow coordination of different jurisdictions, agencies, and disciplines to communicate with one another directly in the response phase of a large-scale incident. The interoperability plan also authorizes stations licensed under Part 90 to communicate with US Government stations "in connection with mutual activities" without further licensing considerations. The Draft MOU highlights limitations of the FCC authorization as noted in Part 90 rules and regulations. Fixed base repeater operations will be limited to the recovery phase of a major incident with an anticipated operational period of 30 to 120 days, by the approval of the REACT International President and/or the Communications Coordinator. The agreement allows coordinated use of mobile repeater pairs and low power portable simplex frequencies in the VHF and UHF authorizations in either analog or digital modes. The agreement calls for the formation of a Communications Committee whose members are made up from teams with an active MOU. Mr. Mahon, is President of Southeastern Massachusetts REACT Team 6240 and a member of the Training & Development Committee.
